



2019 Booth Alcohol Request

Deadline to request permission for alcohol to be served in your booth is December 3, 2018.

Exhibitors are permitted to have alcoholic beverages served from their exhibit booth space only with express written approval of PPAI. Alcoholic beverages may only be served during the following dates and times. No exceptions will be made:

■ Tuesday, January 15 – 1:30 PM – 5:00 PM

■ Wednesday, January 16 – 1:30 PM – 5:00 PM

REGULATIONS:

- Mandalay Bay Convention Center is an exclusive facility in terms of food and beverage. Any and all food and beverage items must be purchased through the facility. Under no circumstances are exhibitors permitted to perform the actual service of alcoholic beverages in the facility. Only Mandalay Bay bartenders hired by the exhibitor are permitted to serve alcoholic beverages. Sale of alcoholic beverages by exhibitor is expressly prohibited.
- Forms for ordering food and beverage from Mandalay Bay catering, including alcoholic beverages, are included in the Online Exhibitor Service Manual.
- Serving of alcoholic beverages must be maintained within the boundaries of the exhibitors' booth space. Serving of alcoholic beverages must not interfere with another exhibit. No lines will be permitted that extend into the aisles.

Insurance: The Exhibitor, at its own expense, must secure and maintain through the term of this contract the insurance listed below. A) Workers' Compensation and Employer's Liability insurance complying with all federal laws and laws of the state of Nevada; B) Comprehensive General Liability insurance with limits not less than \$1,000,000 each occurrence, \$2,000,000 aggregate, combined single limit for bodily injury and property damage, including coverage for personal injury, contractual, and operation of mobile equipment, products and liquor liability (if applicable); C) **Host Liquor Liability with limits not less than \$1,000,000 each occurrence for companies serving alcohol.** Comprehensive General Liability and Host Liquor Liability insurance policies shall name as additional insureds PPAI, its directors, officers, employees and agents, and Mandalay Bay Corp., Mandalay Bay Resort Group and its subsidiaries and affiliates and their officers, employees and agents. **Copies of additional insured endorsements, primary coverage endorsements and complete copies of policies, satisfactory to PPAI, shall be furnished to PPAI thirty (30) days before the first day of the Event. Certified copies of the Certificate of Insurance or policies shall provide that they may not be canceled without 30 days' advance written notice to PPAI.**

Indemnification: Exhibitor shall indemnify, defend, and hold harmless PPAI, its directors, officers, employees, agents, members, guests and the Mandalay Bay Corp., Mandalay Resort Group and its subsidiaries and affiliates and their officers, employees and agents from any claims, demands, suits, liabilities, damages, losses, costs, reasonable attorneys' fees and expenses which result from or arise out of or in connection with (a) Exhibitor's participation or presence at the Event, (b) a breach by Exhibitor of any agreements, covenants, promises or other obligations under this contract (c) any matter for which Exhibitor is otherwise responsible under the terms of this contract; (d) any violation or infringement (or claim of violation or infringement) of any law or ordinance or the rights of any party under any patent, copyright, trademark, trade secret or other proprietary right; (e) any libel, slander, defamation or similar claims resulting from the actions of Exhibitor; (f) harm or injury (including death) to Exhibitor; and (g) loss of or damage to property or the business or profits of Exhibitor, whether caused by negligence, intentional act, accident, act of God, theft, mysterious disappearance or otherwise.
